## INFORMATION LETTER Certain Amendments in Legislation on Foreign Employees

In addition to the amendments in legislation of the Republic of Kazakhstan (Kazakhstan) in the sphere of foreign labor engagement mentioned in our Information Letter of 30 March 2018, we have some more recent news this month worth paying attention, especially by employers using foreign employees.

- 1) Starting 28 April 2018, no foreign labor engagement permits will be required in respect of the 1<sup>st</sup> category employees (chief executive officers and their deputies) of local legal entities with 100% foreign participation in the charter capital<sup>1</sup>. At the same time, it is unclear what will happen to the permits for this category of employees that have already been issued (will they remain valid until expiration or be recognized as automatically terminated). Another issue is whether the members of a collective executive body, other management bodies of legal entities (management board, supervisory board, etc.) or directors not united into a collective executive body will be deemed equal to the "deputies of the chief executive officer", or the companies must stipulate a specific position "deputy of the chief executive officer" in the staff schedule to engage foreign employees without permits. The answers to this and other questions associated with such legislation amendments will be given by practice.
- 2) The 72-hour visa-free regime to enter, stay and exit from Kazakhstan is established for the citizens of the People's Republic of China (PRC) and the Republic of India (RI) flying by the Kazakhstan airlines (subject to availability of valid air tickets of local air companies) to third countries through the international airports of Astana and Almaty. Such visa-free regime if effective for the citizens of PRC starting 19 December 2017<sup>2</sup>, and will become effective for the citizens of RI starting 28 April 2018<sup>3</sup>. The visa-free regime will end at 11:59 PM on 31 December 2018. This category of foreign citizens is to be registered by the Border Service of the National Security Committee of Kazakhstan at the state border checkpoints of Kazakhstan, followed by the issuance of migration cards specifying the time of crossing the state border of Kazakhstan. The local air companies provide the lists of citizens of PRC and RI flying through and using the 72-hour visa-free regime to the Border Service of the
